The Waseca County Board of Commissioners met in a work session on Tuesday, January 19, 2021, in the public meeting room, 300 North State Street, Waseca, Minnesota. Members present were Chair DeAnne Malterer, Doug Christopherson; Brian Harguth; Blair Nelson and Brad Krause.

Others present were Michael Johnson, County Administrator; Tammy Spooner, Auditor-Treasurer; Melissa Sexton, Human Resources Manager; Rachel Cornelius, County Attorney; and John Donahue.

Chair Malterer called the Work Session to order at 8:09 a.m. Roll call was taken and the Pledge of Allegiance was recited.

Mark Leiferman, Planning & Zoning Administrator, provided information on Transfer of Development Rights. The current program was established in 2009.

Michael Johnson, Administrator, presented organizational structure information outlining roles and responsibilities.

WASECA COUNTY BOARD OF COMMISSIONERS — JANUARY 19, 2021

The Waseca County Board of Commissioners met in regular session on Tuesday, January 19, 2021, in the boardroom, 300 North State Street, Waseca, Minnesota. Members present were Chair DeAnne Malterer, Doug Christopherson, Brian Harguth, Blair Nelson, and Brad Krause.

Others present were Michael Johnson, Administrator; Tammy Spooner, Auditor-Treasurer; Melissa Sexton, Human Resources Manager; Rachel Cornelius, County Attorney; and Brad Milbrath, Sheriff.

Chair Malterer called the meeting to order at 9:30 a.m. Roll call was taken and the Pledge of Allegiance was recited.

Harguth moved and Nelson seconded to approve the Agenda with the addition of an Request for Board Action for Non-Renewal of County Engineer Appointment and to pursue options for interim engineering services. Motion carried unanimously.

There was no public comment.

Russ Guse, Ditch Inspector, presented three bids for cleaning and re-sloping County Ditch #48. Guse recommends awarding the project to H & H Excavating, Inc., who was the low bidder. Christopherson moved and Krause seconded to approve the project with H & H Excavating in the amount of \$53,150.00. Motion carried unanimously.

Tammy Spooner, Auditor-Treasurer, presented the recommended 2021 Crop Damage Rates as calculated by our Ditch Viewers. Krause moved and Christopherson seconded to set the 2021 Crop Damage Rates as follows. Motion carried unanimously.

- Corn damage rate 197.7 bushels @ \$3.83 = \$761 per acre
- Bean damage rate 56.1 bushels @ \$10.57 = \$593 per acre

Russ Guse requested to reimburse Duane Swenson, for repairs he made to the county tile on his own in 2013. Mr. Swenson believed it was his responsibility, when it was in-fact a county tile on County Ditch #48. Christopherson moved to reimburse Duane Swenson in an amount not to exceed \$1,300.00. The motion died for lack of a second. Further discussion was held. Christopherson moved and Nelson seconded to approve payment to Mr. Swenson up to \$1,300.00 for reimbursement, upon receipt of the paid invoice. Motion carried 3-2 by the following roll call: Christopherson-aye; Harguth-nay; Nelson-aye; Krause-aye and Malterer-nay.

Harguth moved and Christopherson seconded to approve the Minutes from December 15, 2020 Commissioner Meeting; December 31, 2020 Check Run; and Minutes from January 5, 2021 Commissioner Meeting. Motion carried unanimously.

Nelson moved and Harguth seconded to approve the Consent Agenda as presented. Motion carried unanimously.

Harguth moved and Nelson seconded to approve the extension with a request for a detailed report of progress. Motion carried unanimously.

Michael Johnson, Administrator, requested to approve final payment of \$239,132.15 to Blue Scope for the Solid Waste & Recycling Facility reconstruction project. Harguth moved and Krause seconded to approve the payment to Blue Scope in the amount of \$239,132.15. Motion carried unanimously.

Michael Johnson, Administrator, requested to set a bid opening for February 23, 2021 for Contract #81211 for bituminous materials for annual seal coating work. Nelson moved and Christopherson seconded to set the bid opening for February 23, 2021 at 1:00 p.m. Motion carried unanimously.

Michael Johnson, Administrator, requested to set a bid opening for February 23, 2021 Contract #81212 bituminous pavement work for the Snake Trail project (CSAH 22). Krause moved and Christopherson seconded to set the bid opening for February 23, 2021 at 1:00 p.m. Motion carried unanimously.

Michael Johnson, Administrator, requested adoption of Resolution 2021-4 for Non-Renewal of Appointment of County Engineer. Harguth moved and Nelson seconded to adopt Resolution 2021-4. Motion carried unanimously.

Correction of Clerical Error on Total Budget Number
2021 Waseca County Budget

WHEREAS, Minnesota Statutes 375A.06 provides that the County Administrator shall prepare and submit to the County Board a proposed annual budget including detailed estimates of revenues and expenditures and enforce the provisions of the budget when adopted by the County Board; and

WHEREAS, budget documents have been prepared and the County Board has met in regular sessions for the purpose of adopting a proposed budget for fiscal year 2021; and

WHEREAS, the County Board has come to the conclusion that the budget so prepared is adequate and meets Minnesota Statute provisions;

NOW, THEREFORE, BE IT RESOLVED by the Waseca County Board of Commissioners in and for the County of Waseca, Minnesota, does hereby adopt a budget of \$29,626,090.00 to be certified to the County Auditor/Treasurer. A copy of the budget summary statement is attached to this resolution.

BE IT FURTHER RESOLVED by the Waseca County Board of Commissioners in and for the County of Waseca, Minnesota, does hereby adopt a final tax levy of \$17,068,927.00 reflecting a 1.95% increase to be certified to the Waseca County Auditor/Treasurer as shown in the below table summary.

PURPOSE/ACTION REQUESTED

Transferring 911 monies to the 2021 Waseca County Sheriff's Office budget for the dispatcher being trained in.

SUMMARY

Similar to other Consent Agenda Items, Feedlot Site Inspection Team (FSIT) meeting reports are provided to the Commissioners for information and acknowledgement.

SUMMARY

The Waseca County Feedlot Site Inspection Team conducted an online public hearing on January 14th, 2021, at 2:25 pm for a new feedlot proposed by Isaac and Melissa Eaton. A public notice was mailed out to all landowners on record within one mile of the building site on December 30th, 2020. The site is located in the NE¼ of the NW ¼, Section 21, Otisco Township, Waseca County. A Site Team meeting was required for this proposal according to the Waseca County UDC, Article 6, Section 6.1 (e) (iv) as stated here:

The Feedlot Site Inspection Team shall be required to conduct a site inspection of any proposed new feedlot of over ten (10) animal units. Site inspection shall be conducted for any change in operation or when the animal units will increase by two hundred (200) animal units or greater within a two (2) year period. The Feedlot Officer shall establish a meeting date and time for an onsite inspection with the feedlot owner/operator within thirty (30) days of notification of the feedlot owner/operator's intent for any new construction or expansion when a site inspection is required. The County Feedlot Officer shall execute notification to the Feedlot Site Inspection Team. The Feedlot Officer shall, not later than ten days (10) days before the site inspection, provide notice by mail of the time and date of the site inspection to each property owner within one (1) mile of the proposed feedlot. A minimum of four (4) Feedlot Inspection Team members shall conduct the feedlot inspection.

RECOMMENDATION

Waseca County staff recommends the Waseca County Board of Commissioners move to approve the Consent Agenda.

Feedlot Site Inspection Team (FSIT) Meeting Background

The Waseca County Feedlot Site Inspection Team (Site Team) held an online public meeting for the proposed Eaton Goat Ranch LLC new feedlot site construction on January 14th, 2021 at 2:25pm in the Waseca County East Annex Building large conference room. Site Team members were physically on site at approximately 1:15pm before the public meeting for an inspection and review of the site. Public notices were mailed out to all landowners on record within one mile of the building site, in Waseca County, and a notice was also sent to the Otisco Township Board members on December 30th, 2020. The site is located in the NW¼ of Section 21 in Otisco Township of Waseca County. A site team meeting was held for this feedlot proposal according to the Waseca County Unified Development Code, Article 6, Section 6.06 (e) because it is a proposed new feedlot site that is over ten animal units. The applicants were the only ones that attended the online public hearing.

Otisco Township Officer: Absent

For this new feedlot construction, Waseca County will be responsible for the issuance of this report as well as a Waseca County Construction Short Form and Waseca County Zoning Permit. The new feedlot site will also have to register with the Minnesota Pollution Control Agency (MPCA) because the site is a new feedlot greater than 50 animal units and submit a notice of construction or expansion of an animal feedlot with less than 300 animal units form.

- One comment was received before the FSIT meeting via phone on 1/5/21 from Harlan Gekeler who lives at 29675 145th St. Waseca, MN just north of the proposed feedlot site. Harlan commented that he had “no problems with the project and glad that they are able to build and do their thing.”

Site Description

The site is approximately 5.5 miles south of the City of Waseca and 5.5 miles north of the City of New Richland. The site is located in an area that is surrounded primarily by agricultural farmland with rural farmsteads and small tracts containing single-family homes. The parcel containing the site has a PID of 08.021.1050 and is approximately 7.5 acres in size and located at the intersection of 290th Ave and 285th Ave

The approximate distances to the three closest residences are:

1. Helen R Bagne—2,640 feet (southeast on parcel 08.021.0400)
2. Janet Rudolph Trustee and Arlene M. Nelson Trustee—3,360 feet (northwest on parcel 08.017.0700)

3. Eric A. and Patti M Kalis—3,530 feet (south on parcel 08.021.0300)

Property Owner/Applicant Proposal

The applicants are proposing a new feedlot that will consist of converting a 40ft x 80ft section of the existing machine shed onsite into a total confinement barn to house 400 goats, as well as constructing three 40ft x 40ft total confinement barns, to each house 200 goats. All barns will be dirt floor with manure pack storage that will be cleaned out in approximately 6 week intervals.

The goats will be raised for meat production and will be grown onsite from approximately 30lbs up to 120lbs. Goats of this size have an animal unit (AU) equivalent of 0.15AU. After all construction, the site will have the capacity to house a total of 1,000 head of meat goats, for a total of 150AU. The site plan for the property and proposed barns is shown in Exhibit "A".

Findings of Fact

1. Zone: This site is located in the Agricultural Protection District. According to the Waseca County Unified Development Code Article 6, Section 8, the creation of a feedlot is a permitted use pursuant to the Feedlot Site Inspection Team process.
2. Setbacks/Standards: The immediate site setbacks that met and apply to this proposed feedlot include: a) road centerline: 300 feet; b) property line: 80 feet; c) well: 50 feet for feedlot and 100 feet for stockpile. Other setbacks that were also met for the site, but are not limited to, include: a) residence: 1,000 feet; b) water course: 300 feet c) wetland 300 feet.
3. Feedlot Permit: A construction short form and zoning permit will be issued by Waseca County for the construction of the feedlot facilities.
4. Access: An existing driveway serves the site from 290th Ave.
5. Topography: The topography of the barn placement location is relatively flat. The overall site gradually slopes southward.
6. Well: The current well in use will continue to serve the property and constructed feedlot facilities. The property also contains an additional well that was closed in 1948 according to the Waseca County Public Health Department records. The well is classified as unused/unsealed because proper documentation of the decommission process was not filed and recorded.
7. Septic: The applicants are not planning on installing bathroom/shower facilities in the barns.
8. Manure Management: Manure generated at the feedlot will be hauled and surface applied to agricultural crop fields as weather and field conditions allow. Onsite stockpiling of manure will take place when applications are not feasible. 285 acres are available for manure application on parcels 08.016.0400,

08.022.0900, and 08.021.1000. Approximately 62 acres are needed annually for application of manure generated onsite.

9. Aesthetics: Parcel 08.021.1050 contains a mature grove of trees that will act as a vegetative screening of the barns.
10. Mortality Management: Onsite rendering and offsite composting will be used for animal mortality management.

Concerns/Comments of the public and FSIT:

- Increased impervious surface from the addition of the proposed barns was discussed by the FSIT. Stormwater runoff from the barn's roofs and maintaining site cover vegetation were addressed with the applicant during the FSIT's onsite inspection.
- No comments or concerns were received during the public comment portion of the online public hearing.

Recommendations of the FIST

By consensus, the Feedlot Site Inspection Team agreed with the following recommendations for this site:

1. **Unused/Unsealed Well:** Feedlot and property owners shall voluntarily investigate the status of the unused/unsealed well onsite with a licensed well contractor to certify that the well was properly sealed or complete necessary steps for closure/sealing of the well.

General Conditions:

2. All standards and requirements of the Waseca County Unified Development Code including Specific Standards for Animal Agriculture ("Feedlot Ordinance") must be met.
3. In addition to the requirements of this development ordinance, all uses and development shall comply with all other applicable city, county, state, and federal regulations. This includes but is not limited to (i) Minnesota Pollution Control Agency Rules, Chapter 7020.0100 - 7020.1900, Rules for the Control of Pollution from Animal Feedlots, as amended from time to time, and (ii) Minnesota Statute 169.88 (Financial liability of owner and/or operator of a vehicle that damages public roads).
4. If a provision of this ordinance conflicts with any other provision of this ordinance, the Waseca County Unified Development Code, or with any other provision of law, the more restrictive provision shall apply, except as otherwise provided.
5. This document shall be recorded with the Waseca County Recorder at the property owner's expense.

Feedlot Property Owners and Operations Manager Acknowledgement:

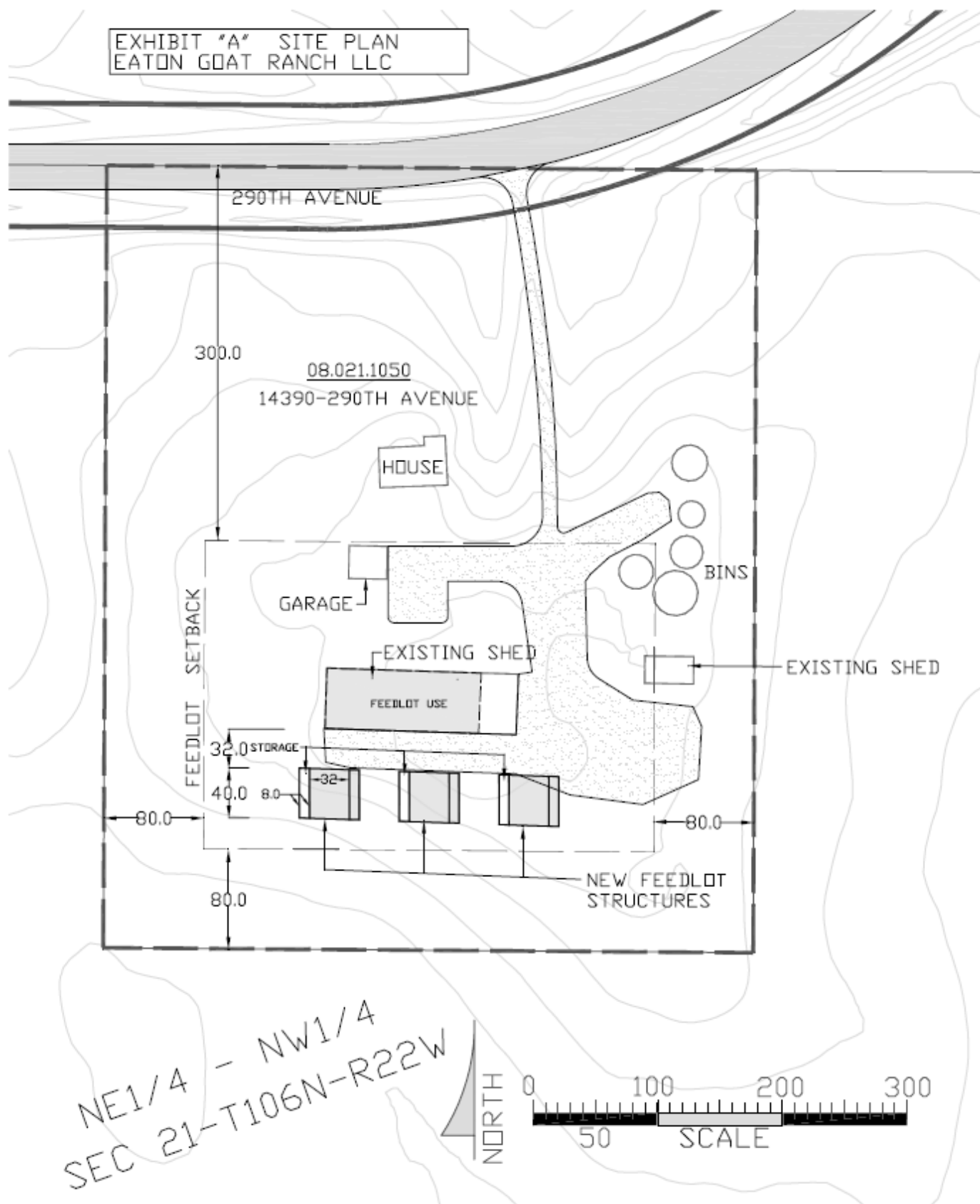

PURPOSE/ACTION REQUESTED

I am requesting ratification of Amendment No. 7 to Maintenance and Support Agreements for Property Tax and CAMA with MnCCC for services with Conduent / Avenu.

SUMMARY

In 2012, our vendor, Conduent / Avenu, began re-writing the Property Tax and CAMA programs. After 8+ years, our group with Minnesota Counties Computer Cooperative (MnCCC), has voted to discontinue extending the contract. We have been continuing support on the current system, which is a “green screen” program and we will need to continue the support while we search for another vendor and convert to new programs.

RECOMMENDATION

Waseca County staff recommends that the Waseca County Board of Commissioners ratify Amendment No. 7 for Maintenance and Support Agreement for Property Tax and Amendment No. 7 for Maintenance and Support Agreement for CAMA and authorize the Board Chair and County Auditor/Treasurer to sign the agreements.

**AMENDMENT NO. 7
TO
MAINTENANCE AND SUPPORT AGREEMENT – PROPERTY TAX**

This Amendment No. 7 to Maintenance and Support Agreement (this "Amendment") is made and entered into by and between the Minnesota Counties Computer Cooperative ("MCCC") and Conduent State and Local Solutions, Inc. ("Conduent") successor in interest to Conduent State & Local Solutions, Inc., referred to individually as "Party" or collectively as "Parties." In consideration of the mutual obligations set forth herein, the Parties mutually agree to amend the Agreement as follows:

1. This Amendment shall be effective on June __, 2020 (the "Amendment Effective Date").
2. Article 2, Term of Agreement, is deleted in its entirety and replaced with the following:

The term of this Agreement shall commence on June __, 2020 (the "Effective Date"), and will continue through December 31, 2023. This Agreement can be extended for additional years based on mutually agreed to pricing terms negotiated by the Parties.

3. As of the Amendment Effective Date, Article 3, Maintenance and Support Services to be Provided by ACS is deleted in its entirety and replaced with the following:

Beginning on June __, 2020, and continuing through the term of this Agreement, Conduent will furnish MCCC and the members of the Conduent Property Tax User Group with the services set forth in Exhibit A - Statement of Work, attached hereto and made part hereof.

Withdrawal of Counties shall be addressed as follows: It is the intent of the parties that all of the Initial Participating Counties ("IPC's") will continue to receive maintenance and support hereunder for the three-year term at the per County rates set forth in Table 1. There are twenty-five (25) IPCs under this Agreement. The parties acknowledge and agree that nineteen (19) Counties is the "Minimum Participating Threshold" ("MPT") under this Agreement. To the extent the total number of participating Counties falls below the IPC but remains at or above the MPT, the quarterly rate will be adjusted on a per county basis for which the price will be subject to a pro rata reduction for each withdrawn county down to the MPT. If the total number of participating Counties falls below the MPT, the total price paid by MCCC shall remain equal to the MPT price. For the avoidance of doubt, the parties acknowledge and agree that under no circumstances will the per county rate comprising the total price paid by MCCC drop below the MPT. The price to MCCC upon the withdrawal, termination or removal, of any County or Counties between the IPC and MPT shall be adjusted at the quarterly price per Table 2. The withdrawal, termination, or removal of an MCCC member County covered by this Agreement shall be confirmed in writing and shall not be a basis for reduction or modification of the total three year price payable by MCCC.

MCCC acknowledges and agrees that each member of the Property Tax User Group who ratifies this Agreement will be bound by the general terms and conditions specified herein, including but not limited to the service provision terms contained in Exhibit A.

4. As of the Amendment Effective Date, in Exhibit B of the Agreement, Applicable Charges, the section titled "Tax Support" is deleted in its entirety and replaced with the following:

For the MCCC member counties who are members of the Conduent Property Tax User Group (which consists of the following counties: Beltrami, Benton, Brown, Dodge, Faribault, Fillmore, Freeborn, Goodhue, Houston, Hubbard, Jackson, Kanabec, Kittson, LeSueur, Martin, McLeod, Otter Tail, Pennington, Pine, Sibley, Wabasha, Waseca, Watonwan, Winona and Wright Counties), MCCC shall pay Conduent the quarterly maintenance & support fees set forth below.

5. Notification of cancellation should be provided 12 months in advance per the original contract and should be done prior to May 15 of each year.
6. Avenu will continue to maintain a support staff to support this product and customers.
7. All terms and conditions of the Agreement, except as expressly amended herein, shall remain in full force and effect.

Upon written request, Avenu will provide MnCCC pricing for upgrade path to our legacy Tax solutions as part of this support and maintenance agreement. Avenu may propose any one of several modules and features listed below to meet the desired objectives for a property tax solution. Each of these may be purchased separately or as a fully integrated bundle with our CAMA solutions. Our proposed pricing includes implementation and support services required for each of the solutions including project management, data conversion, and training.

Clearview Property Tax Manager (PTM): Property Tax Billing, Collection, and Assessment Administration modules are intended to conform to each jurisdiction's business rules. The objective is to provide workflows and calculations that adapt to a County's administrative requirements. The Property Tax Billing and Collections modules are designed to provide end to end management of the entire Tax cycle, and together the modules provide tools and administer assessments for each jurisdiction.

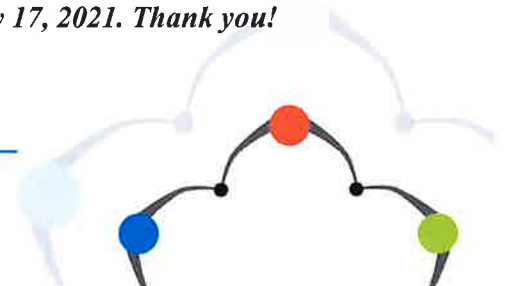

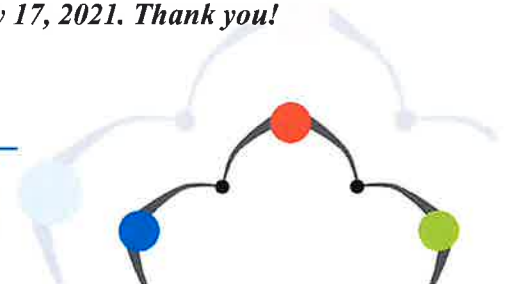
