SUMMARY

Upon our request, the Ditchviewers have established a Crop Damage Rate Schedule for 2021. This is a fair and impartial assessment and final determination by uninterested parties.

Waseca County Crop Damage Rate for 2021

It is the policy of Waseca County to set a rate of pay for crop damages that may occur due to repair, improvement, or construction projects. This is done at the beginning of the year for the entire year.

The yield is determined by using a three year average yield for Waseca County from data received from the USDA. (National Agricultural Statistics Services)

The sale price is determined by using an average sale price for “new crop” corn and beans from three local elevators on January 3, 2021.

Corn damage rate 198.7 bushels @ \$3.83 = \$761 per acre

Bean damage rate 56.1 bushels @ \$10.57 = \$593 per acre

WASECA COUNTY BOARD OF COMMISSIONERS — DECEMBER 15, 2020

The Waseca County Board of Commissioners met in regular session on Tuesday, December 15, 2020, in the boardroom, 300 North State Street, Waseca, Minnesota. Members present were Chair Doug Christopherson, Brian Harguth, Blair Nelson, DeAnne Malterer and Brad Krause.

Others present were Michael Johnson, Administrator; Tammy Spooner, Auditor-Treasurer; Russ Guse, Ditch Inspector; and Brad Milbrath, Sheriff; Nathan Richman, County Engineer; Lyle Sopkowiak, Assistant County Engineer. A representative of the Waseca County News was present via the online platform.

Chair Christopherson called the meeting to order at 9:30 a.m. Roll call was taken and the Pledge of Allegiance was recited.

There was no public comment.

Krause moved and Nelson seconded to approve the Agenda as presented. Motion carried unanimously.

Russ Guse, Ditch Inspector, requested approval for repairs to ditches.

Nelson moved and Krause seconded to approve payment for buffer mowing to control weeds on CD #51 in Vivian Township in the amount of \$2,880.00. Motion carried unanimously.

Nelson moved and Krause seconded to approve projects on CD #8 in the amount of \$2,967.75 for buffer work plus \$2,000.00 for beaver dam removal. Motion carried unanimously.

Malterer moved and Krause seconded to approve crop damage payments on JD #10 to Larry Huber in the amount of \$846.86; Orlin Bauman in the amount of \$2,582.66; and Shirley Hansel Trust in the amount of \$3,201.66. Motion carried unanimously.

Nelson moved and Harguth seconded to approve buffer mowing on CD #6 in New Richland Township in the amount of \$2,385.00.

Malterer moved and Harguth seconded to approve buffer mowing on CD #47 in the amount of \$832.50 and CD #26 in the amount of \$585.00, both in New Richland Township. Motion carried unanimously.

Malterer moved and Krause seconded to approve mowing, stump grinding, and seeding along CD #3 in the amount of \$11,685.00 buffer. Motion carried unanimously.

Harguth moved and Krause seconded to approve mowing, seeding, tree removal, and beaver dam removal on Jt. CD #1, near Lake Elysian, in the amount of \$9,792.75. Motion carried unanimously.

Malterer moved and Nelson seconded to approve replacement of 900 feet of tile main on JD #51 in Section 16 of Vivian Township in the estimated amount of \$18,500.00. Motion carried unanimously.

Krause moved and Harguth seconded to approve replacement of 1,500 feet of tile/pipe, in Section 11 of Otisco Township, and reseed the CRP buffer on JD #5 at an estimated cost of \$7,000.00. Motion carried unanimously.

At 9:55 a.m. a Public Hearing was held regarding the county fee schedule. Michael Johnson, Administrator, presented the fee schedule and indicated the purpose of

the process was to consolidate all county fees into one schedule. There are no new fees at this time. The Public Hearing was opened for comments at 10:05 a.m. There was no public comment. Malterer moved and Krause seconded to close Public Hearing at 10:06 a.m. Motion carried unanimously. Harguth moved and Malterer seconded to adopt Resolution 2020-48 approving the fee schedule. Motion carried unanimously.

**Resolution #2020-48
2021 Waseca County Fee Schedule**

WHEREAS, Minnesota Statutes 373.41 provides that the County may charge fees for services provided by any county office, official, department, court or employee; and

WHEREAS, the County Board may, after public hearing, establish the amounts of fees to be charged for the services unless a statute has specified the amount; and

WHEREAS, there must be a reasonable relation between the fee and the cost of providing the service; and

WHEREAS, Waseca County staff review their fee schedules each year for reasonability and compliance.

NOW, THEREFORE, BE IT RESOLVED by the Waseca County Board of Commissioners in and for the County of Waseca, Minnesota, does hereby adopt the 2021 Waseca County Fee Schedule as presented to their governing body, in-person, on December 15, 2020, and after holding public hearing, as part of their regular meeting.

Michael Johnson, County Administrator, presented a request to accept a County Veterans Services Office Operational Enhancement Grant in the amount of \$10,000.00. Harguth moved and Krause seconded to adopt Resolution #2020-45 to accept the grant. Motion carried unanimously.

**RESOLUTION # 2020-45
RESOLUTION OF WASECA COUNTY**

BE IT RESOLVED by **Waseca County** that the County enter into the attached **Grant Agreement** with the Minnesota Department of Veterans Affairs (MDVA) to conduct the following Program: **County Veterans Service Office Operational Enhancement Grant Program**. The grant must be used to provide outreach to the county's veterans; to assist in the reintegration of combat veterans into society; to collaborate with other social service agencies, educational institutions, and other community organizations for the purposes of enhancing services offered to veterans; to reduce homelessness among veterans; and to enhance the operations of the county veterans service office, as specified in Minnesota Statutes 197.608 and Minnesota Laws 2019, Chapter 10 Article 1, Section 37, Subdivision 2. This Grant should not be used to supplant or replace other funding.

BE IT FURTHER RESOLVED Waseca County that **Christopher Hinton** the **County Veterans Service Officer**, be authorized to execute the FY2021 CVSO Grant Agreement (an example of which is attached) for the above-mentioned Program on behalf of the County.

Tammy Spooner, Auditor-Treasurer, requested authorization to transfer \$333,000.00 from the General Fund (01) to the Ditch Fund (41) to cover deficit balances on individual ditches. This transfer is to be a loan with a 1% annual rate of interest. Krause moved and Malterer seconded to approve the transfer. Motion carried unanimously.

Tammy Spooner, Auditor-Treasurer, requested to transfer \$523,612.54 from the Ditch Fund (41) to the General Fund (01) to repay prior years' loans on ditches that have an adequate balance to repay. The repayment is \$510,959.16 principal and \$12,653.37 interest. Malterer moved and Krause seconded to approve the transfer. Motion carried unanimously.

Tammy Spooner, Auditor-Treasurer, presented a list of ditch assessments to place on the 2021 tax rolls. She requested approval of the assessments and a decision by the Board of Commissioners regarding interest on the multi-year assessments. Krause moved and Harguth seconded to approve the assessment schedule and to charge 2.5% interest on the assessments that are amortized over more than one year. Motion carried unanimously.

Tammy Spooner, Auditor-Treasurer, presented a Legal Services Agreement from Rinke Noonan for services for the Drainage Authority. County Attorney, Rachel Cornelius, has reviewed the document. Spooner recommends approving the agreement with Option 1 for a \$200 per month retainer fee, which is the same monthly fee we have been paying for many years. This offers the best value for answering general drainage questions. Nelson moved and Malterer seconded to approve the agreement with Option 1 for the fee structure. Motion carried unanimously.

Nathan Richman, County Engineer, requested to purchase a Ford F550 crew cab pickup truck from Deml Ford, who had the low quote. Nelson moved and Harguth seconded to approve the purchase from Deml Ford in the amount of \$42,099.00. Motion carried unanimously.

Nathan Richman, County Engineer, requested to purchase a box and hoist for the new crew cab pickup from Crysteel Truck Equipment. Malterer moved and Harguth seconded to approve the purchase from Crysteel Truck Equipment in the amount of \$13,993.00. This decision is based on delivery and service at a cost \$84.00 higher than the low quote. Motion carried unanimously.

Nathan Richman, County Engineer, presented purchase amounts and lease amount for a riding shop sweeper. After review, Richman requested to purchase an Advance SW8000 riding shop sweeper from Nilfisk, Inc. with the low quote. Nelson moved and Malterer seconded to purchase the Advance SW8000 shop sweeper from Nilfisk, Inc. in the amount of \$41,111.60. Motion carried unanimously.

Mark Leiferman, presented a revised Greater Blue Earth River Basin Alliance Joint Powers Agreement and requested approval of the agreement. Harguth moved and Krause seconded to approve and enter into the revised joint powers agreement. Motion carried unanimously.

Michael Johnson, Administrator, shared information regarding the Budget and Levy Meeting and presented Resolution #2020-46 to approve the 2021 Budget with a 1.95% Levy increase. Harguth moved and Malterer seconded to adopt Resolution 2020-46. Motion carried unanimously.

**Resolution # 2020-46
2021 Waseca County Budget**

WHEREAS, Minnesota Statutes 375A.06 provides that the County Administrator shall prepare and submit to the County Board a proposed annual budget including detailed estimates of revenues and expenditures and enforce the provisions of the budget when adopted by the County Board; and

WHEREAS, budget documents have been prepared and the County Board has met in regular sessions for the purpose of adopting a proposed budget for fiscal year 2020; and

WHEREAS, the County Board has come to the conclusion that the budget so prepared is adequate and meets Minnesota Statute provisions;

Waseca County sent a letter to Deloris Boerigter and advised the Cease and Desist Order is still in effect on her property regarding her wedding barn/event center. Staff asked her to provide documentation that she is making progress on the project and that if she cannot the County would be forced to cancel her Conditional Use permit. The letter gave her until February 1, 2021 to provide the documentation.

Deloris Boerigter called staff on January 13, 2021 and indicated she has a contractor at her facility installing/reinstalling doors to meet exit requirements. Staff explained the critical factor in allowing wedding to continue was to complete the plans to show the building meets Minnesota State Building Code Requirements and then to complete the improvements outlined in the plans. Staff provided Deloris the name of the architect used by two other County Agri-tourism to meet state code requirements. She indicated she would contact the architect. Staff provided the plans in our files to the architect. Staff suggested Ms. Boerigter provide a formal request to extend the deadline to the Planning and Zoning Department. She said she would do so. Staff will provide the letter upon receipt by staff.

Since her facility does not operate during the winter months, staff does not feel the extension of the deadline will put the public at risk. Ms. Boerigter indicated she has never booked a wedding before May in the past.

RECOMMENDATION

Staff recommends extending the timeframe for compliance for 60 days (April 1, 2021) and consider further extensions if progress is made on compliance with the requirements and provided the factors prohibiting large gatherings stay in place.
